SCOPE AND CONTENT

Record Group 68 houses the records of the Fairlington Commons Board of Directors. Its members, elected by the Council of Co-Owners, formed the Board to oversee Fairlington Commons during the transition phase between rental units and condominium ownership, and then to govern the Commons. The collection consists of materials from the Board of Directors' files, including items such as by-laws, annual reports, treasurer reports, committee minutes and other miscellaneous materials with scattered dates from 1973-1992.

Fairlington Commons was founded in 1973 with the conversion of the Fairlington apartment complex to condominiums. Its Board of Directors, from its inception, has dealt with problems such as financial management, building maintenance, grounds upkeep, and rubbish collection. The records in this collection provide a look at issues faced by individuals living in a typical apartment-to-condominium conversion, a situation common in the Arlington community.

The collection occupies .7 linear ft.

RESTRICTIONS

There are no research restrictions on this Record Group.

PROVENANCE

Record Group 68 accretion #1 was donated in 1994 by the Fairlington Commons Board of Directors. Accretion #2 was donated by Frances Rossiter in March 1998.
